Center for Anxiety's Internship Program currently offers eight full-time internship positions (2 positions in Manhattan, 2 positions in Brooklyn, 2 positions in Rockland County, 2 positions in Great Neck). Center for Anxiety bases its selection process on the entire application package submitted through AAPI; however, applicants who have met the following qualifications prior to beginning internship are considered preferred:

1. A minimum of two years of supervised practicum experience involving provision of psychotherapy;
2. Practicum experience or special interest in working with evidence-based treatment methods, particularly CBT and DBT, in outpatient and intensive outpatient settings;
3. Dissertation proposal defended;
4. Current enrollment and good standing in an APA-accredited or CPA-approved clinical, counseling, school, or combined psychology doctoral program.

Interns are also allotted two paid holidays (July 4 and Thanksgiving). Interns are also provided with 5 days of professional development time and/or dissertation-related activities, which will be counted as non-paid time off (travel days for professional development are counted towards PTO). All interns have access to our employee benefits package, which includes employer-negotiated rates on medical insurance, funding for professional development (\$750 for interns), comprehensive and fully paid malpractice insurance, partial reimbursement for employee fitness, and paid parental leave.
